

TN Assembly Election 2026

Velachery:

1. Rebuilding of the Community Hall that was demolished at Besant Nagar, without converting it into a commercial complex.
2. Removal of TASMACH from 1st Avenue, Besant Nagar; near Kasturba Nagar MRTs. Other TASMACH Shops within or near to residential area across the constituency.
3. To eradicate drug menace across the constituency in general and especially in and around Besant Nagar.
4. To bring back proper police patrolling system to ensure the safety of the residents
5. Retrieve the public space along the Cart Street between 1st Avenue, Besant Nagar, and Sastri Nagar and remove the bottleneck.
6. Cancel the lease given to a private party for the amusement park on Elliot's Beach.
7. To retrieve the OSR land that an educational institute in Gandhi Nagar has illegally occupied.
8. To reduce the number of stalls on the sands of Elliot's beach. To have just two food court one on northern side and another on Southern side run by the fishermen community through a society.
9. To take action on CRZ violation on the beach
10. To shift the Turtle conservation centre from Guindy National Park to the beachfront.
11. Bringing a Government Arts & Science College to the constituency
12. Stop converting the TNHB-developed housing area into a commercial area

13. To replace the Thuraipakkam Pallikaranai road with a cable bridge to facilitate the connectivity of the fragmented Pallikaranai Marsh.
14. Chennai One, NIOT are in the marsh, and the NGT has given orders to vacate these from the Marsh.
15. The encroachment on the waterways that run along the Perungudi and Velachery station road till the seven vents connecting the Pallikaranai Marsh needs to be removed.
16. To hand over the dump yard to the Wetland authority after biomining and stop dumping any waste in the marsh.
17. To close the petrol bunk in the Gandhi Nagar bus terminus and redevelop the terminus
18. To redevelop the PHU and Fish market on 1st Avenue, Besant Nagar
19. To ensure more water bodies are created inside the race course
20. The Sastri Nagar ration shop that has been constructed illegally on the road is to be relocated to an appropriate land within Sastri Nagar.
21. To develop the playground in Sastri Nagar and Besant Nagar.
22. To provide bus service linking Besant Nagar and Kotturpuram.
23. To shift the Vijayanagar Bus terminus next to the Velachery MRTs.
24. Bus stop shelters in front of GRT, and to have a bus stop for Shastri Nagar towards Besant Nagar.
25. To stop building vendors from using the road as their open godown.
26. To have safe, encroachment-free footpaths across the constituency.
27. To credit the old age pension directly into the beneficiaries' account.

28. To name the metro rail station that is under construction at LB road as “Shastri Nagar” Metro Station.
29. To have slaughter house in the constituency to ensure safe and healthy meat and prevent illegal slaughtering at the vending place with out approval of veterinarian.
30. To retrieve the Sastri Nagar ground on 1st Cross Street, which has been handed over to a private School and put to public use.

In General:

1. To stop the Mamallan Project, which will destroy the Nemmeli brackish water lagoon.
2. The State Higways in the process of widening the road eliminates green component without leaving scope for green corridor which is a component of roads.
3. To stop landfilling of existing waterbodies and reclassifying them for real-estate.
4. To recommend bifurcation of our constituency into Adyar and Velachery or atleast to name as Adyar-Velachery Constituency.
5. To declare Kotturpuram Urban Forest as a protected urban forest (Biodiversity hotspot).
6. To have public consultation before proposing any project for our constituency.
7. To conduct a meeting at ward level once in three months.
