As per BBMP notification of 25/07/2013, BBMP mandate (Bulk Generators which includes domestic generators-apartments complexes in more than 50 units and institutional and commercial bulk generators who produce more than 10 kg of Municipal Solid Waste) Bulk generators to segregate waste into different categories and manage their waste either in-situ or to utilize the services of BBMP Empanelled Service Providers.

BBMP has acknowledged the high level of generator dependency on private waste vendors, as well as the paucity of such vendors in the market. Accordingly, BBMP is implementing this program to facilitate the Bulk Generators and to get competition and professional vendor services as well as ensure waste is being handled responsibly.

Objectives of the program

- ❖ Professionalizing the waste management industry
- ❖ Introducing norms and standards for SWM service providers
- ❖ Opening out the SWM market and facilitating healthy competition
- ❖ Ensuring licensed service providers follow waste management rules and guidelines
- ❖ Facilitating segregation at source through planned collection/transportation systems
- ❖ Reducing waste sent to landfills by determining destinations and accountability
- ❖ Enabling EPR models by encouraging recycling and processing

Empanelment of vendors has been executed keeping the following factors in mind:

- a) Category of waste being handled
- b) Capacity for waste management
- c) Geography of destination (to promote a decentralized model)
- d) Technology used at destination

Without a clear idea of the empanelled vendor's waste management capacity and destination, it will be impossible to set up a transparent and efficient system. The following destinations have been defined as appropriate for empanelled vendors:

Category	Destination
Dry	Dry Waste Collection Center (DWCC), Recycler, Scrap-Dealer
Wet	Composting Facility, Bio-Meth Unit, Organic Waste Composter
Sanitary	Incinerator and Autoclave
Green	Shredder, Park composting
C & D	Quarry

The Bulk Generators who are processing or willing to process their waste onsite (insitu) shall avail assistance from the agencies having expertise.
